

America's 250th Installer Grill Giveaway – Official Terms & Conditions

1. Promotion

The America's 250th Installer Grill Giveaway ("Promotion") is organised and administered by AES Global ("Promoter").

The Promotion celebrates America's 250th Anniversary by giving away one (1) BBQ grill each month for six (6) consecutive months to eligible installers selected by random raffle.

2. Promotion Period

The Promotion begins on July 1st, 2026 and ends on December 20th, 2026.

One winner will be drawn each month from all eligible entries received during that month's promotion period.

3. Eligibility

- Open to professional installers who are 18 years of age or older.
- Participants must be legal residents of the United States.
- Employees of AES Global, its affiliates, distributors, agencies, and their immediate family or household members are not eligible.
- Entries must relate to genuine installations completed during the Promotion Period.

4. How to Enter

Participants can enter by submitting their installation via SMS to the AES Global Technical Support number.

Entries are awarded as follows:

- One (1) completed installation photo = One (1) raffle entry.
- One (1) selfie with the completed installation plus a short testimonial = Two (2) raffle entries.

Each qualifying installation counts as a separate entry.

5. Multiple Entries

- There is no limit to the number of qualifying entries submitted during the Promotion.
- Duplicate photos or multiple submissions of the same installation may be removed.
- AES Global reserves the right to reject fraudulent, manipulated or otherwise invalid entries.

6. Monthly Prize Draw

- One winner will be selected at random each calendar month.
- Winners will be contacted using the mobile number from which the entry was submitted.
- If a winner cannot be contacted within seven (7) days, or fails to respond, another winner may be selected.
- Winners may be required to verify their eligibility and provide any information reasonably requested by AES Global before the prize is awarded.

7. Prize

- One (1) BBQ grill will be awarded each month.
- The prize is non-transferable, non-refundable and cannot be exchanged for cash.
- AES Global reserves the right to substitute the prize with one of equal or greater value if circumstances require.

8. Customer Permission

By entering, participants confirm they have obtained permission from the property owner or customer to photograph the completed installation and submit those images to AES Global for promotional purposes.

Participants are solely responsible for ensuring they have all necessary permissions before submitting any photographs.

9. Content Ownership & Marketing Licence

By submitting a photograph, the entrant represents and warrants that they own the photograph or have obtained all necessary rights, permissions, and consents to submit it, including any

required permission from the property owner or identifiable individuals depicted. The entrant irrevocably grants Advanced Electronic Solutions Global Inc., its affiliates, successors, licensees, and assigns, a perpetual, worldwide, royalty-free, fully paid, transferable, sublicensable, non-exclusive license to use, reproduce, modify, publish, distribute, display, create derivative works from, and otherwise use the photograph, in whole or in part, in any media now known or later developed, for any lawful business purpose, including advertising, marketing, promotional, and commercial uses, without further notice, approval, or compensation. The entrant releases and agrees to hold harmless Advanced Electronic Solutions Global Inc. from any claims arising from such use, agrees to indemnify the Company for any breach of these representations, and acknowledges that the Company has no obligation to use any submitted photograph and may edit or modify it at its sole discretion.

No additional payment or compensation will be provided for the use of submitted content.

10. Publicity

Unless prohibited by law, winners agree that AES Global may publish their:

- Company name
- State
- Submitted photographs
- Testimonials

for promotional and marketing purposes without additional compensation.

11. Content Requirements

Submitted content must:

- Show a genuine completed installation.
- Not contain offensive, defamatory or inappropriate material.
- Not infringe any copyright, trademark or intellectual property rights.
- Not include confidential customer information.
- Not display personal information such as addresses, alarm codes, gate access codes or vehicle registration numbers where reasonably possible.

AES Global reserves the right to remove or reject any submission it considers unsuitable.

12. Safety

Participants must never take photographs or selfies while driving, operating machinery, working at height without appropriate safety measures or carrying out unsafe working practices.

Entries showing unsafe behaviour may be disqualified.

13. Shipping

Prizes will be shipped to addresses within the United States.

Any shipping restrictions, including Alaska, Hawaii or U.S. territories, will be communicated to winners where applicable.

14. Privacy

Personal information collected during the Promotion will only be used for administering the Promotion, contacting winners and, where consent has been provided, future marketing communications, in accordance with the AES Global Privacy Policy.

15. Odds of Winning

The odds of winning depend on the total number of eligible entries received during each monthly promotion period.

16. Taxes

The winner is solely responsible for any and all federal, state, and local taxes, fees, or other governmental assessments associated with the acceptance, receipt, ownership, or use of the prize. Sponsor makes no representations regarding the tax consequences of accepting the prize. Winners are encouraged to consult their own tax advisor regarding any tax obligations. All eligible entries received during the Promotion Period will have an equal opportunity to be selected in the applicable monthly drawing.

AES Global shall not be liable for any interruption, communications failure, technical malfunction, system error or other event that prevents the Promotion from operating as intended.

20. General Conditions

AES Global reserves the right to:

- Verify the validity of all entries.
- Disqualify any participant who tampers with the entry process, submits false information, attempts to manipulate the Promotion or otherwise breaches these Terms & Conditions.
- Amend, suspend or cancel the Promotion where circumstances beyond its reasonable control make this necessary, including but not limited to natural disasters, cyber incidents, government action or supply chain disruption.
- Make the final decision regarding all aspects of the Promotion.

The Promoter's decisions are final.

21. Limitation of Liability

By participating, entrants agree to release and hold harmless AES Global, its affiliates, directors, officers, employees, distributors and agents from any claims, damages, losses or liabilities arising out of participation in the Promotion or the acceptance, use or misuse of any prize, except where prohibited by law.

22. Governing Law

These Terms & Conditions shall be governed by and interpreted in accordance with the laws of the State of Florida, without regard to its conflict of law principles.

A list of monthly winners will be made available upon reasonable written request for up to ninety (90) days following the conclusion of the Promotion.

24. Acceptance
